**TRADE NAME CHANGE OR  
BUSINESS ENTITY NAME CHANGE**

**CHECKLIST OF REQUIRED DOCUMENTS**  
(must be single sided with no staples)

- Permit Application and Report of Changes application (State form- DR8442)- completed in pertinent area, listing old current name as trade name and old name and also listing new name, and signed under oath of applicant section by authority representative of licensee applicant.
- Business Entity name change supporting documents. For trade name changes, state form is all that is needed and no secretary of state amendment documents are needed. For business entity name changes for corporations, limited liability companies, or partnerships, applicant must submit filed certificate of amendment from the Colorado Secretary of State's website. If you cannot produce the certificate of amendment from the secretary of state showing that the licensee business entity is still the same, only the name has changed, then a transfer of ownership filing may be warranted.
- Fees:
  - \$50 state change fee payable to "Colorado Department of Revenue." Paid online at <https://secure.colorado.gov/payment/liquor>
  - \$50 city change fee payable to "City of Boulder." Paid online at [https://energovcss.bouldercolorado.gov/EnerGov\\_Prod/SelfService](https://energovcss.bouldercolorado.gov/EnerGov_Prod/SelfService)
- Application Process: Licensing Office will: i) If the necessary application form, supporting documents, and proper fees are submitted, then trade name changes and business entity name changes can usually be signed by the City of Boulder indicating local approval and mailed to the state liquor enforcement division without delay. Beverage Licensing Authority (BLA) hearing will only be required if new name is in some way controversial warranting BLA oversight and hearing. ii) Licensing database should have change status updated to indicate form forwarded to state and updated to list the new name (with old name listed under conditions section for 1 year to ensure tax continuity). iii) Permanent license file should be updated with new name by records. iv) When received back, state approved copy of state form should be mailed to licensee applicant's business mailing address for their records.

Submit the necessary information and proceed to page 5 for Oath of Applicant signature. Retail Liquor License submit to Local Liquor Licensing Authority (City or County).
